उपरोक्त विषयांकित प्रकरणी, महाराष्ट्र स्वयं अर्थसहाय्यित शाळा (स्थापना व विनियमन) अधिनियम, २०१२ आणि महाराष्ट्र स्वयंअर्थसहाय्यित शाळा (स्थापना व विनियमन) नियम, २०२० अंतर्गत शैक्षणिक वर्ष २०२३-२४ पासून समाज विकास शिक्षण क्रीडा व बहुउद्देशिय सेवा मंडळ, मु.पो.चिंचाम्बा भर, ता.रिसोड जि.वाशिम द्वारा संचालित ब्रम्हा व्हॅली पब्लीक स्कुल, बालाजी सुतगिरणी समोर, मांगवाडी, ता.रिसोड जि.वाशिम या इंग्रजी माध्यमाच्या नवीन प्राथमिक ते माध्यमिक (इ. १ ली ते १० वी, इंग्रजी माध्यम, सी.बी.एस.ई.) स्वयंअर्थसहाय्यित तत्वावर नवीन शाळा सुरू करण्याकरिता, अटी व शर्तीसह इरादा पत्र दिले होते. सदर संस्थेस नवीन शाळा सुरू करण्याची मान्यता, पुढील अटी व शर्तीस अधिन राहून शासनाकडून देण्यात आलेली आहे.

अटी व शर्ती :-

- १) प्रस्तावित शाळा, बालकांचा मोफत व सक्तीच्या शिक्षणाचा हक्क अधिनियम, २००९ आणि महाराष्ट्र बालकांचा मोफत व सक्तीच्या शिक्षणाचा हक्क नियम, २०११ यांद्वारे निर्धारित केलेल्या सर्व मानकांची, अटींची व शर्तींची आणि या अधिनियमान्वये शासनाने दिलेल्या निदेशांची किंवा शासनाने, वेळोवेळी निर्दिष्ट केलेल्या मानकांची किंवा प्रमाणकांची किंवा अटींची आणि शर्तींची पूर्तता करील.
- २) नोंदणीकृत संस्थेने किंवा न्यासाने किंवा कंपनीने, महाराष्ट्र स्वयं अर्थसहाय्यित शाळा (स्थापना व विनियमन) अधिनियम, २०१२ याद्वारे निर्धारित केलेल्या सर्व मानकांचे, अटींचे व शर्तींचे आणि या अधिनियमान्वये शासनाने दिलेल्या निदेशांचे किंवा शासनाने, वेळोवेळी निर्दिष्ट केलेल्या मानकांचे किंवा अटींचे आणि शर्तींचे पालन करणे अनिवार्य आहे.
- ३) सी.बी.एस.ई. किंवा सी.आय.एस.सी.ई. किंवा सी.ए.आय.ई. किंवा आय.बी. इत्यादी मंडळाच्या संलग्नतेसाठी इच्छुक शाळा व्यवस्थापनांनी, शासनाने वेळोवेळी दिलेल्या निर्देशानुसार, शासनाकडून ना-हरकत प्रमाणपत्र घेणे अनिवार्य आहे.
- ४) शाळा व्यवस्थापन, शासनाने मंजूर केलेल्या शैक्षणिक वर्षाची सुरुवात करण्यापूर्वी संबंधित जिल्हयाच्या शिक्षण अधिकाऱ्यास कळवील.
- ५) या अधिनियमाच्या तरतुदीअन्वये नवीन शाळेची स्थापना करण्यासाठी किंवा शाळेचा दर्जावाढ करण्यासाठी दिलेली परवानगी, ती ज्या शैक्षणिक वर्षासाठी मंजूर केलेली आहे. त्याच वर्षासाठी असेल.
- ६) जर शाळा व्यवस्थापन, १८ महिन्यांच्या आंत, शाळा सुरू करण्यास अपयशी ठरल्यास, दिलेले मान्यतापत्र रद्द होईल.
- ७) शाळा व्यवस्थापनास, मंजूर केलेले शिक्षणाचे माध्यम, शाळेचे ठिकाण, भविष्यात, शासनाच्या परवानगीशिवाय बदलता येणार नाही.
- ८) जर शाळा व्यवस्थापनाने, शासनाने मंजुरी दिलेल्या ठिकाणाव्यतिरिक्त अन्य ठिकाणी शाळा स्थापन केली असेल तर, त्या शाळेची परवानगी रद्द होईल.

- ९) अशी तरतुद करण्यात आली आहे कि, स्वयं अर्थसहाय्यित शाळेतील शिक्षक व शिक्षकेतर कर्मचाऱ्यांची भर्ती शासनाच्या प्रचलित नियमानुसार व विनियमानुसार करण्यात यावी.
- १०) जिल्हानिहाय माहिती भरतेवेळी, ज्या शाळेस परवानगी देण्यात आली आहे, ती शाळा, स्वतंत्र प्रवर्ग म्हणून - "स्वयंअर्थसहाय्यित शाळा" अशी माहिती भरतील व यु.डी.आय.एस.इ. क्रमांक मिळवतील. या संबंदात, राज्य प्रकल्प संचालक, महाराष्ट्र प्राथमिक शिक्षण परिषद, मुंबई यांस, नोडल अधिकारी म्हणून घोषित करण्यात आले आहे.
- ११) शाळा व्यवस्थापन, शाळा परिसराच्या प्रवेशद्वारावर - "स्वयंअर्थसहाय्यित परवानगीप्राप्त शाळा" असा फलक लावतील.
- १२) या अधिनियमाच्या कोणत्याही किंवा त्याखाली केलेल्या नियमांच्या तरतुदीचा भंग केल्याच्या किंवा अधिनियमान्वये दिलेल्या कोणत्याही निदेशांचे किंवा शासनाने वेळोवेळी निर्दिष्ट केलेल्या मानकांचे किंवा प्रमाणकांचे अथवा अटी व शर्तीचे अनुपालन करण्यात कसूर केल्याच्या कारणावरून, कोणत्याही वेळी, राज्य शासन, दिलेले मान्यता पत्र रद्द करू शकेल.
- १३) सदर संस्थेने किंवा न्यासाने किंवा कंपनीने अधिनियमाच्या "अनुसूची ग" मध्ये विनिर्दिष्ट केलेली रक्कम व्यवस्थापन आणि संबंधित शिक्षणाधिकारी (माध्यमिक) यांच्या नावे संयुक्तरित्या, राष्ट्रीय बचत प्रमाणपत्राच्या स्वरूपात किंवा कोणत्याही राष्ट्रीयकृत बँकेतील मुदत ठेविच्या स्वरूपात ठेवणे आवश्यक राहिल. तसेच प्रस्तूतची मान्यता ही तपासनीचे अधिन राहून देण्यात येत असून, तपासनीमध्ये त्रुटी/अनियमितता आढळल्यास दिलेली मान्यता रद्द समजण्यात येईल.

Reference: Government Recognition Letter No. SFS-1016/P.No.69/SM-2, dated 17 June 2016

In the above-mentioned case, a letter of intent was given with terms and conditions to start a new school on a self-financed basis from the academic year 2023-24 under the Maharashtra Self-Aided Schools (Establishment and Regulation) Act, 2012 and the Maharashtra Self-Aided Schools (Establishment and Regulation) Rules, 2020 to the **Brahma Valley Public School, opposite Balaji Sut Girni, Mangwadi, Tal. Risod, Dist. Washim, operated by the SAMAJ VIKAS SHIKSHAN KRIDA VA BAHUUDDESHIYA SEVA MANDAL, Mu. Po. Chinchamba Bhar Ta. Risod Dist. Washim, for starting a new school on a self-financed basis from primary to secondary (Class 1 to 10, English Medium, and CBSE) of English medium. Approval to start a new school has been given by the Government subject to the following terms and conditions.**

Terms and Conditions:-

- 1) The proposed school shall comply with all the standards, terms and conditions prescribed by the Right of Children to Free and Compulsory Education Act, 2009 and the Maharashtra Right of Children to Free and Compulsory Education Rules, 2011 and the directions given by the Government under this Act or the standards or standards or standards specified by the Government from time to time.
- 2) It is mandatory for the registered institution or trust or company to comply with all the standards, terms and conditions prescribed by the Maharashtra Self-Aided Schools (Establishment and Regulation) Act, 2012 and the directions given by the Government under this Act or the standards or standards specified by the Government from time to time.
- 3) C.B.S.E. or C.I.S.C.E. or C.A. I.E. or I. B. It is mandatory for school managements desirous of affiliation to the Board, as per the instructions issued by the Government from time to time, to obtain a 'No Objection Certificate' from the Government.
- 4) The school management shall report to the Education Officer of the concerned district before the commencement of the academic year approved by the Government.
- 5) The permission granted under the provisions of this Act to establish a new school or to upgrade the status of a school shall be for the academic year for which it is approved.





- 6) If the school management fails to start the school within 18 months, the approval granted shall be cancelled.
- 7) The school management shall not be able to change the approved medium of education or the location of the school in future without the permission of the Government.
- 8) If the school management establishes a school at a place other than the place approved by the Government, then the permission of that school shall be cancelled.
- 9) It is provided that the recruitment of teachers and non-teaching staff in self-aided schools should be done as per the prevailing rules and regulations of the Government.
- 10) While filling the district-wise information, the schools to which permission has been granted shall fill the information as "Self-aided Schools" as a separate category and shall obtain UDISE number. In this regard, the State Project Director, Maharashtra Primary Education Council, Mumbai has been declared as the nodal officer.
- 11) The school management shall put up a board at the entrance of the school premises stating "Self-aided Permitted Schools".
- 12) The State Government may cancel the letter of recognition granted at any time on the ground of violation of any provision of this Act or the rules made thereunder or failure to comply with any directions given under the Act or the standards or norms specified by the Government from time to time or the terms and conditions.
- 13) The said institution or trust or company shall be required to keep the amount specified in "Schedule C" of the Act jointly in the name of the management and the concerned Education Officer (Secondary) in the form of National Savings Certificate or in the form of Fixed Deposit in any nationalized bank. Also, the approval of the present is being given subject to the investigation, and if any error/irregularity is found in the investigation, the approval given shall be deemed to have been revoked.

Subject: Action to be taken regarding school names

It has been observed that in the proposals received by the State Authority, many schools have names that include terms such as *International*, *Global*, *CBSE*, etc. Some schools also mention *English Medium* in their names, even though their recognition is granted as Marathi medium schools.

In reality, while naming schools, the use of words like *International* or *Global* implies that the school has international-level infrastructure and standards, which may not actually exist. Similarly, the term *CBSE* is being used in some school names, which is inappropriate because CBSE is the name of a specific educational board established by the Government of India.

Considering this situation, the use of terms such as *International*, *Global*, *CBSE*, *English Medium* in school names may mislead govt. parents, students, and society. This can create confusion and misunderstanding.

Therefore, during the meeting held on Dt. 10/12/2025 by the State Authority regarding proposals for granting recognition to new self-financed schools, it was discussed that such names may negatively impact parents and students. It is necessary to clearly justify the use of such terms in school names. If such justification is not valid, the concerned schools should be instructed to change their names.

Accordingly, while examining proposals for new school recognition, the school's name, management, medium and comparison with other similar schools should be considered. If the name is found misleading or inappropriate, necessary action should be taken to change it.

All concerned officers and school managements are instructed to implement these directions strictly. Existing schools using such terms in their names should also take corrective action.

By the end of December 2025, a report of such cases should be submitted to the State Authority.
